HRDF TRAINING PROVIDER

Intellectual Property Technology Sdn Bhd is a Human Resources Development Fund (HRDF) approved training provider. We are allowed to conduct training programmes under the SBL scheme. All our training programmes conducted are HRDF claimable.

HRDF is administered by Pembangunan Sumber Manusia Berhad (PSMB), an agency under the Ministry of Human Resources Malaysia. Under the HRDF Act 2001, employers in the manufacturing sector, with more than 50 employees, or 10 to 49 employees and a paid-up capital of RM 2.5 million and above are required to register with HRDF. Every employer who is required to register with HRDF has to pay a levy in respect of each of his employees at the rate of 1% of the monthly salary of the employee.

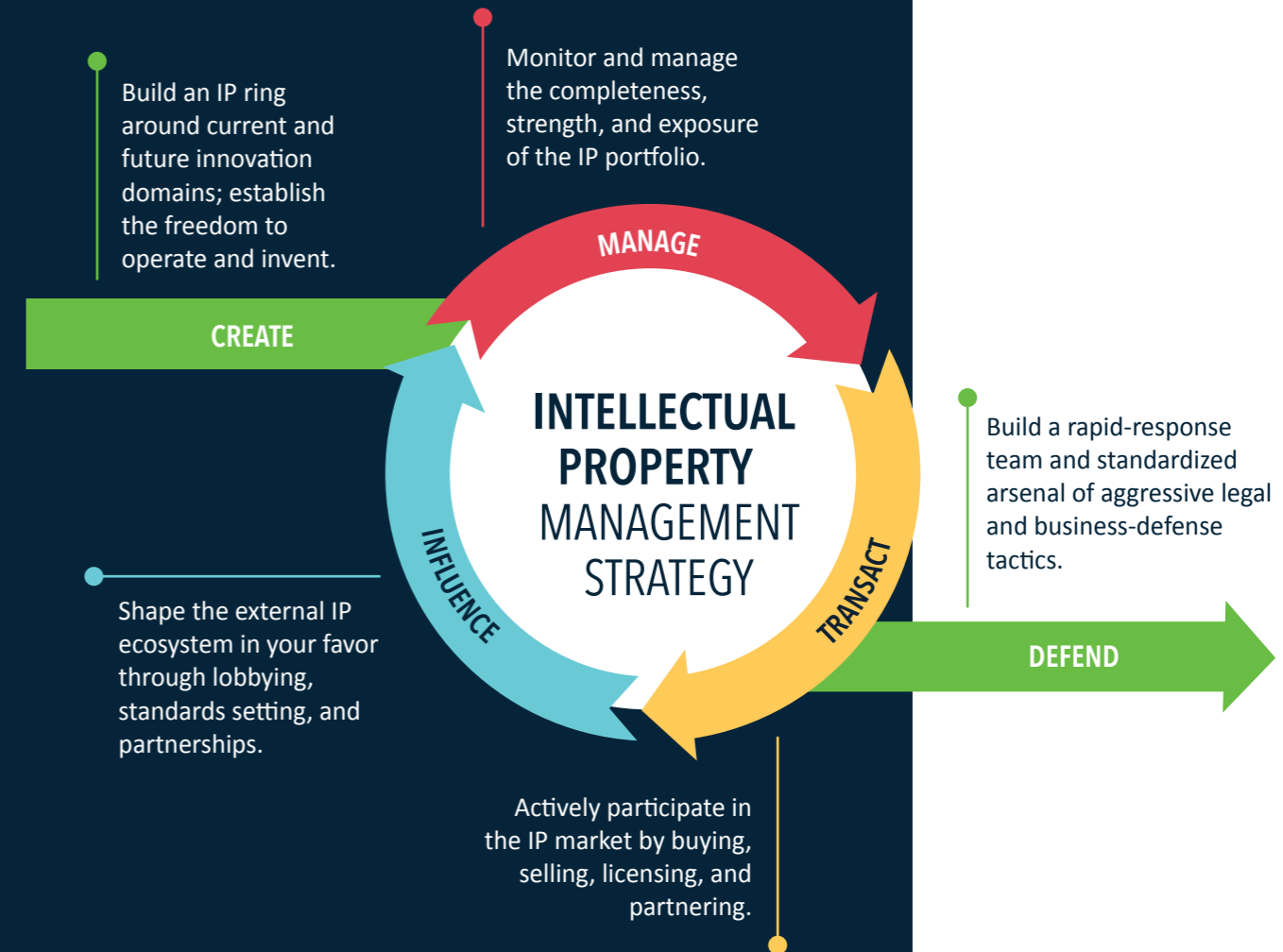
Employers who have registered with HRDF and paid the levy for the first month of registration are eligible to apply for training grant (financial assistance) to defray all or a major portion of the "allowable costs" of training their employees. They are eligible to access their levy payments by claiming training reimbursement through various training schemes that are implemented by HRDF.
